GENERAL RULES FOR EXHIBITORS (DOMESTIC)

- 01. **The Southern Gujarat Chamber of Commerce & Industry** (hereinafter referred as the **Organizer** or the **Chamber** and such individuals or body of individuals as authorized by it.
- 02. The **Exhibitor(s)** Any Individual or Group of individuals, Company, Organization, Firm or its employee(s), Contractors or Sub-contractors or Licensee (hereinafter referred as the **Exhibitors / Sponsors** or the **Party**)

Whereas

- The Chamber is organising an exhibition entitled **Surat International Textile Expo SITEX '24 (9th Edition)** during **6th to 8th January, 2024** as detailed under.
- The Party has expressed interest to participate in the exhibition.
- 03. **Venue:** Surat International Exhibition & Convention Centre (SIECC), Bhatar Althan Road, Nr. Khajod Crossing, Sarsana, Surat-395007, Gujarat, India.
- 04. **Exhibition Timings:** 10 AM to 6 PM.
- 05. Booking of Space Both Indoor and Outdoor, may be made in combinations / multiples of contiguous Plots/ Booths. For a combination of contiguous, furnished Indoor Standard Booths allotted, provision of partitions within the area would be optional.

It is hereby stated that

The Exhibitors

- 06. The Exhibitor enters into agreement upon submission of this document. The Party (Prospective Exhibitor) agrees to participate at *Surat International Textile Expo SITEX '24 (9th Edition)* and to abide by the Rules and Regulations and By-Laws laid out by the organizer before the exhibition. Any breach of contract by the Exhibitor, will lead to confiscation of space rentals in full, by the chamber.
- 07. The Exhibitor will be required to make payment of any damage inflicted to the Ground Facilities / Building / Infrastructure etc. during Setting Up / Exhibition Period and / or Dismantling Period, as determined by the chamber.
- 08. The Party is required to pay Participation / Sponsorship charges at the time of submitting the application. No application shall be entertained without the payment of the participation charges.
- 09. No exhibitor will be allowed to change the exterior layout, paint the interior, or change the standard format for the Company's name banner. No painting or touching will be permitted at the exhibition under any circumstances. Removal of partition between stall is not permitted. Violation of rules and damage to the property including the Furniture, Fitting, Frame etc. will attract penalties as determined by the chamber and debited to party's account and shall have to be paid by the party before vacating the stall.

- 10. Any alteration in the size or position of a stall is not permitted. No posters or banners are allowed outside the stall. The exhibitor is prohibited to assign, sublet grant licenses in respect of the whole or any part of the stall. Cards, Advertisement or Printed Matter by individuals or Firms who are not bonafide exhibitor will not allowed to be exhibited or distributed.
- 11. The exhibitor must have, at all times valid and adequate insurance cover against Theft, Fire, Public Liability, Damage to Property, Personal Injury, Third Party Loss, Accidents, Natural Calamities, Acts of God and such other risks normally insured against by the exhibitors. The exhibitor's property is brought to display and stored at, and removed from the exhibition centre at the exhibitor's own risk and the exhibitor is responsible for the safety of its property and personal at all times.
- 12. The party shall not disclose/share any information on booking, facilities and related matters to any other exhibitor(s) except otherwise permitted by the chamber.
- 13. Creating any nuisance like playing music, which may disturb other participants, is strictly prohibited. (Max 65D)
- 14. All on site electrical installations shall have to be carried out by the officially appointed Electric Contractor before the connection to the main supply.
- 15. The organizer will make best efforts to ensure uninterrupted power supply, fire services, water, sanitation etc, However, these services are provided by DGVCL, SMC and other bodies. Any disruption or failure in these services and/or loss/damage thereupon shall not be the responsibility of the service provider or the chamber. The exhibitors will not be entitled to any allowance / reimbursement of any kind in that respect.
- 16. No material once exhibited will be allowed to be taken outside the exhibition without prior permission of the organizer.
- 17. The removal of exhibits will be allowed only after all dues have been cleared & relevant certificate obtained.
- 18. Normally once a stall is booked and amount paid, cancellation request will not be entertained. However, the discretion of the organiser certain refund may be allowed as per instruction (Page No. 3) in the application form.

The Organizers

- 19. The organizer will provide a round the clock security in the exhibition premises. However, surveillance by individual security guards can be provided at extra cost.
- 20. The organizer and/or its authorized person(s), have the right to enter the stall premises at any time to Execute Work, Repairs, Alterations and for other purpose which it deems necessary.
- 21. Due to unavoidable circumstances and/or natural calamity, the exhibition date may be pre- or postponed in which case no refund will be given.
- 22. Additional Power Requirement will be provided at extra charges and the requirements of the same will be submitted before the deadline mentioned.
- 23. Additional items like Tables, Chairs, Electric Fixtures, MH Halogen etc. will be provided at extra charges.
- 24. Notwithstanding the above rules and conditions, the chamber reserves the right to amend and/or discard /add any or many rules and conditions without assigning any reason(s) thereof and notice to the party.
- 25. In the event of any dispute, the decision of the President of the SGCCI or its Authorised nominee shall be final and binding.
- 26. Subject to Surat jurisdiction.
